Special Accomplishments

Catholic Identity—

- ✓ The students performed a Living Rosary during the month of October.
- ✓ Students participated in morning and afternoon prayer and received religious instruction of the Catholic Faith on a daily basis.
- ✓ Students attended mass on First Fridays and Holy Days participating in the Liturgy of the Word, Choir and as altar servers.
- ✓ In celebration of Vocation Awareness Week, girls in grades three through eight enjoyed a visit with several Novices from the IHM Community.
- ✓ The school community celebrated a special Thanksgiving and Commitment Service for students making the sacraments of Reconciliation, First Holy Communion and Confirmation.
- ✓ Students celebrated Advent and Lent with special masses and spiritual activities including Adoration of the Eucharist, Stations of the Cross and Penance.
- ✓ Students celebrated Catholic Schools Week themed “Catholic Schools: Communities of Faith, Knowledge and Service.” The students celebrated with a special mass, family activities and service projects throughout the week, including a hat, sock and book collection for the students at St. Francis de Sales, a parochial elementary school in West Philadelphia.
- ✓ PJP II school families joined fellow parishioners from St. Peter Parish in the annual March for Life in Washington D.C.
- ✓ Students participated in a May Procession and crowning ceremony in honor of the Blessed Mother.
- ✓ Fifty-four students received the Sacraments of Penance and First Eucharist and seventy-four students received the Sacrament of Confirmation.
- ✓ Girls in grades 3 through 8 served in the IHM Junior Companions in Ministry which is dedicated to love, hope and fidelity through prayer, religious instruction and service. In addition to various service projects, the girls visited Villa Maria House of Studies for a Retreat day and received their Junior Companion pins at a special prayer service.

Service -

- ✓ Students collected personal items during Catholic Schools Week and delivered them to the retired I.H.M. Sisters at Camilla Hall.
- ✓ Several car loads of maternity, infant and children clothes; toys, books and baby equipment from the PJP II Kids' Outgrown Sale were donated to Birthright in Coatesville.
- ✓ Brothers Brady and Devin Manning honored their brother Dylan's memory and other children who suffer or lost their lives to Tay-Sachs and other allied diseases through a Lemonade Stand during the 4th Annual National Tay-Sachs Disease Event for Hope. Fellow classmates participated in this event helping to raise nearly \$3,000 for advanced research.
- ✓ Students and their families donated 700 pounds of canned goods during the Meal in a Can Lenten Food drive and collected nearly 1000 pounds of PB&J for shelters, food pantries and those in need.
- ✓ Students raised nearly \$1,500 in the Adopt-a-Family drive to assist six PJP families during the Christmas season.
- ✓ Senior citizens were invited to a special Christmas concert presented by the PJP II Concert Band and Drama Club singers.
- ✓ PJP II Girl Scout troops made cookies and caroled to local shut-ins, wrapped toys for tots, volunteered at a water station for the “Making Strides” for Breast Cancer walk and made a rag quilt for a woman battling breast cancer.

- ✓ PJP II Boy Scout Troop 16 and Leaders performed approximately 98 man hours of Community Service on projects such as cleaning up the Coatesville River Walk Trail, an Eagle Service Project led by PJP II alum Danny Kilgallon building picnic tables for the Chester County Emergency Services Training Center in Coatesville, planting trees for the Brandywine Conservancy at The Pocopson Home, cleaning up their Adopt-a-Highway section of the Rt. 30 bypass, and provided support for the Coatesville Iron and Steel Museum.
- ✓ CYO sports teams were involved with several service projects throughout the year including: collecting and organizing toys in partnership with the Coatesville CYWA; collecting over 600 lbs. of food for the Chester County Food Bank; adopting several families in need through the CYWA Adopt-a-Family program and providing gifts and a holiday meal to each; raising over \$1000 in a Coaches vs. Cancer charity basketball game and cleaning the Gym bleachers.
- ✓ Students partnered with Partners in Outreach assisting with two campaigns: Partners in Literacy and Operation Easter Outfit. Students collected and donated several hundred books to children in neighboring communities and collected and distributed Easter outfits to local families in need at the Coatesville CYWA and the St. Agnes Day Room.
- ✓ Kindergarten students welcomed Grandparents/Special Persons to school with special activities in honor of Grandparents' Day.

Curriculum and Technology Updates-

- ✓ Students in grades four through eight participated in the Chester County Science Research Competition. Several students were awarded ribbons for their individual and team projects.
- ✓ NASA Summer of Innovation Camp was held onsite offering students knowledge in Robotics, Aero nautics, Rocketry, Earth and Space Science through hands-on activities.
- ✓ The school launched a Lego Robotics program made possible by a grant from The Connelly Foundation.
- ✓ New classrooms on the top floor were equipped with Epson Brightlink interactive projectors to match the same level of technology in the lower level classrooms. Additional WiFi access points were installed to enable students and teachers seamless connectivity, especially in regard to students' iPad use.
- ✓ Sr. Mary Jane Bransfield joined the staff to begin a Campus Ministry program for students, faculty and families.

Facility Enhancements-

- ✓ A targeted capital campaign (*Finishing the Dream*) combined with several fundraising events funded the construction and completion of six new classrooms for the Junior High (7th and 8th grade) students and a Fine Arts room on the top floor of the school. This project will enable new programs on the lower floors including a Pre-K program for three year olds, a resource room for students with special needs, a world language lab, a prayer and spirituality room and an art/science room equipped for our younger students.

Faculty Enrichment -

- ✓ Faculty received Professional Development opportunities and resources for the implementation of the Common Core State Standards, new forms of Technology, Math, Science and English Language Arts and also completed Religion certification classes.
